In terms of the provisions of Section 135 of the Companies Act, 2013 and rules made thereunder, the Company is mandatorily required to spend an amount of \* Rs.48,00,000 (Rupees Forty Eight Lakhs Only) towards CSR activities in the financial year 2022-23. The Board of Directors of the Company has approved a total CSR budget amounting to ₹ 50,00,000 (Rupees Fifty Lakhs Only) to be spent on CSR activities during the financial year 2022-23.

The Company was required to spent an amount of Rs. 42,88,614 (Rupees Forty-Two Lacs Eighty Eight Thousand Six Hundred Fourteen) but had spent an amount of ₹ 44,00,000 (Rupees Forty-Four Lakhs Only) for CSR activities during the financial year 2021-2022.

The excess spent amount of Rs. 1,11,386 (Rupees One Lac Eleven Thousand Three Hundred and Eighty Six) for CSR Activities in the financial year 2021-2022 would be available for set-off against the CSR spending requirement for the next three financial years.

The CSR Committee has recommended the "Corporate Social Responsibility Annual Action Planfor the Financial Year 2022-23" to the Board of Directors of Vehere Interactive Private Limited.

The Board may alter this plan at any time during the financial year, as per recommendation of CSR Committee of the Company, based on the reasonable justification for such alternation to the effect.
